

**MEDICAL MARIJUANA REGULATIONS
FEE SCHEDULES**

I. GENERAL PROVISIONS:

- A. All fees paid under this resolution shall be non-transferable and non-refundable.
- B. In the event professional fees are incurred, such as additional inspector fees, architect fees, surveyors, engineers, attorney fees, etc., or fees associated with Special Meetings or hearings, then those charges are in addition to the below stated fee schedule.
- C. If the application requires a Specific Use permit, then all fees associated with the specific use permit shall be paid prior to the application being reviewed. *(See Zoning Ordinance Fee Schedule Resolution).*
- D. Permittee shall pay all fees and charges before receiving the appropriate permit.
- E. All fees shall be paid simultaneous with submitting the application.
- F. The fees paid shall include all mailing and publication costs for such application, if any.

**II. MEDICAL MARIJUANA RETAILER/DISPENSARY PERMIT APPLICATIONS:
(Ord. #98, Article 2, §9-116)**

The initial fee for a Medical Marijuana Retailer / Dispensary Permit\$1,500.00

The renewal fee for a Medical Marijuana Retailer / Dispensary Permit \$500.00

(The fee schedule for all Medical Marijuana Retailer / Dispensary permit applications includes reviewing and filling out the compliance sheet; checking with the administrative agencies to ensure the business is licensed to operate in the state and licensed to sell marijuana and has the appropriate sales tax permit. It further requires at least 2 initial on sight inspections of the premises to view distance requirements, setbacks, advertising and signage, and compliance with all other town ordinances; and annual inspection thereafter to ensure compliance with all laws. Future inspections to ensure compliance may be necessary. Enforcement may be necessary at a later date.)

**III. MEDICAL MARIJUANA COMMERCIAL GROWER PERMIT APPLICATIONS:
(Ord. #98, Article 3, §9-126)**

The initial fee for a Marijuana Commercial Grower Permit\$1,500.00

The renewal fee for a Medical Commercial Grower Permit \$500.00

(The fee schedule for all Medical Marijuana Commercial Grower permit applications includes reviewing and filling out the certificate of compliance sheet; checking with the administrative agencies to ensure the business is licensed to operate in the State and licensed to grow marijuana. It further requires at least 2 initial on sight inspections of the premises to view the closed structure, security, setbacks, whether it can viewed by the public in a right of way, lighting, plumbing, electrical and compliance with building codes, and all other town ordinances. Future inspections to ensure compliance may be necessary. Enforcement may be necessary at a later date.)

**IV. MEDICAL MARIJUANA PROCESSOR / TESTING PERMIT APPLICATIONS:
(Ord. #98, Article 3, §9-136)**

The initial fee for a Marijuana Processing / Testing Permit \$1,500.00

The renewal fee for a Marijuana Processing / Testing Permit \$500.00

(The fee schedule for all Medical Marijuana Processor / Testing permit applications includes reviewing and filling out the certificate of compliance sheet; checking with the administrative agencies to ensure the business is licensed to operate in the State and licensed to process marijuana. It further requires at least 2 initial on sight inspections of the premises to view security, distance requirements, zoning, setbacks, lighting, plumbing, electrical, commercial grade equipment, ventilation, air filtration systems, security systems, locks, and compliance with all other town ordinances. Future inspections to ensure compliance may be necessary. Fire Chief may have to inspect the premises for both of these applications. Enforcement may be necessary at a later date.)

**V. MEDICAL MARIJUANA EDUCATION AND RESEARCH PERMIT
APPLICATIONS: (Ord. #98, Article 3, §9-149)**

The initial fee for a Marijuana Processing / Testing Permit \$1,500.00

The renewal fee for a Marijuana Processing / Testing Permit \$500.00

(The fee schedule for all Medical Marijuana Processor / Testing permit applications includes reviewing and filling out the certificate of compliance sheet; checking with the administrative agencies to ensure the business is licensed to operate in the State and licensed to process marijuana. It further requires at least 2 initial on sight inspections of the premises to view security, distance requirements, zoning, setbacks, lighting, plumbing, electrical, commercial grade equipment, ventilation, air filtration systems, security systems, locks, and compliance with all other town ordinances. Future inspections to ensure compliance may be necessary. Fire Chief may have to inspect the premises for both of these applications. Enforcement may be necessary at a later date.)

**VI. MEDICAL MARIJUANA WASTE DISPOSAL PERMIT APPLICATIONS:
(Ord. #98, Article 3, §9-156)**

The initial fee for a Marijuana Waste Disposal Permit \$2,500.00

The renewal fee for a Marijuana Waste Disposal Permit \$1,000.00

(The fee schedule for all Medical Marijuana Waste Disposal permit applications includes reviewing and filling out the certificate of compliance sheet; checking with the administrative agencies to ensure the business is licensed to operate in the State and licensed to properly dispose of marijuana. It further requires at least 2 initial on sight inspections of the premises to view security, distance requirements, zoning, setbacks, lighting, plumbing, electrical, commercial grade equipment, ventilation, air filtration systems, site security systems, locks, disposal process standards, and compliance with all other town ordinances. Future inspections to ensure compliance may be necessary. Enforcement may be necessary at a later date.)
